say something

Judge2: "Bailiff, will you place the defendant at the table"

Judge3: "Has the courtroom been searched?"

Tom: "A complete search has been conducted and I can assure

you the court is safe" Tom then brings out the weapons box and shows the weapons that were collected at the door search, especially showing the ball and chain

Judge4: "Will the prosecution identify themselves"

President

Paul: After the reading of the charges, Paul requests three

minutes of recess

Judge1: "Recess granted"

Jim: "I protest"

Judge2: "Protest denied, sit down in your chair"

Paul: Paul tells Bruce that the charges look bad - "Maybe you

should pay for the wine that is being served and certainly include the tribunal; of course, no bribe

intended."

Judge3: "Will the prosecution begin with the opening statement"

Jim: Prosecution gives opening statement:

"The club president should set the highest example of his office

"Frior to office, Mr Curley was a mild mannered, casually dressed family man serving society as a veterinarian.

"Rotary Club presidents are bound to observe, in their official acts, the highest standards of integrity, and to discharge faithfully the duties of this office. The conduct in both their official and private affairs should be above reproach.

"President Bruce has performed acts incompatible with the official duties through the use of intimidation, threats, coercion and influence of office. This is contrary to the purpose of serving your community as an office holder.

"Almaden Rotary expected and should have received the highest standard of ethics from President Bruce. He was elected as an agent of the Rotary purpose and conservator of the club's trust.

"We will prove each of the charges and expect the severest of penalties"

Jay: Dresses Bruce into a veterinary jacket

John: Shows photo of Bruce in a coat and tie with a dignitary

Jim: Charge #4a is Bruce practicing veterinary medicine on

humans

Jerry: Shows transplant photo (Pros exhibit 4a) without Deanna

Bruce remains in the veterinary jacket

Paul: Rebuts charge #4a with Deanna and daughter photo - a

family man

Shows photo (Defense exhibit 4a) Jay:

Jim: Charge #4b is maybe Deanna isn't so sweet and innocent

Is Deanna considering that there is something better?

Muzzv: Shows photo of Deanna and transplant (Pros exhibit 4b)

Paul: Rebuts charge #4b with Deanna photo - How can this

sweet and innocent thing be accused of doing something

unusual, out of the ordinary?

Jay: Shows photo (Defense exhibit 4b)

John: Holds up sign to encourage whistling - WHISTLE

Jim: Charge #4c "Is this an example of being normal ...

typical of normal mannerisms?"

Shows photo of Deanna as "Mickey Mouse" (exhibit 4c) Jerry:

Paul: "Your honors, I would like to request a change of venue"

Judge3: "Request denied"

Jim: Jim begins the fifth charge of Bruce impersonating a

woman (when)

Muzzy: Puts wig on Bruce

John: John interrupts - "Your honor, in view of what has just been heard, seen and presented, we Mr. Lowden and I

would like to change sides. We don't have a chance in hell on this side - we have our reputation to uphold."

Judge4: "Permission granted" Jim: Continues charge #5

Four: Each of the attorneys holds up a photo of Bruce

impersonating a woman (don't let these get away).

Paul: "DEFENSE RESTS!"

Jim: "Prosecution rests"

Judges: Judges convene in a circle and pronounce him guilty

Before reading sentence -

Paul: Paul makes last minute plea for leniency and begins to

place stacks of money in front of the judges

Judges: "Based on the last minute evidence PLACED before us, we
